AIMS AND PURPOSES

The Parochial Church Council (PCC) of Thornton-le-Fylde Christ Church has the responsibility of co-operating with the incumbent, the Reverend Damian Platt, in promoting in the ecclesiastical parish, the whole mission of the Church, pastoral, evangelistic, social and ecumenical. The PCC is also specifically responsible for the maintenance of the Church, Churchyard and Church Hall complex on Meadows Avenue, Thornton-Cleveleys, Lancashire.

OBJECTIVES AND ACTIVITIES

The PCC is committed to enabling as many people as possible to worship at our Church and to become part of our parish community at Christ Church. The PCC maintains an overview of worship throughout the parish and makes suggestions on how our services can involve the many groups that live within our parish. Our services and worship put faith into practice through prayer and scripture, music and sacrament.

When planning our activities for the year, we have considered the Commission's guidance on public benefit and, specifically, the supplementary guidance on charities for the advancement of religion. In particular, we try to enable ordinary people to live out their faith as part of our parish community through:

- Worship and prayer; learning about the gospel; and developing their knowledge and trust in Jesus.
- Provision of pastoral care for people living in the parish.
- Missionary and outreach work – as the local church with global hope

To facilitate this work, it is important that we maintain the fabric of the Church, Churchyard and Church Hall of Christ Church.

MEETINGS AND MEMBERSHIP

Members of the PCC are either ex-officio or elected by the Annual Parochial Church Meeting in accordance with the Church Representation Rules.

Co-opted members also sit on the PCC and function like that of an elected member.

During 2019 the PCC met its obligation of meeting four times during the year.

The Standing Committee is the only committee required by law and it has the power to transact the business of the PCC between its meetings, subject to any directions given by the PCC. The Standing Committee met when needed during the year. The meetings of the Committee are not mandatory.

PCC CHAIRMAN'S REPORT FOR 2019

2019 has been a year of mission. The doors have been open, literally. Monday to Friday, the Church doors have been visibly open during the daytime, so that passers-by can see that Christ Church is here, is open and is the place to be. Starting with Morning Prayer at 8:45 AM in the Chapel, each day of activities has started as it should – with prayer.

Anyone who attends Morning Prayer will start to hear the sound of friction towards the end of the short service – the friction of small wheels rubbing against the church car park – prams! Our very popular Playhouse Baby & Toddler Drop-in starts at 9:00 AM and the most wonderful sound of excitement can be heard as babies and toddlers can be heard arriving excitedly. The first thing they look forward to is seeing the fish tank, or is it? It might be 'Banjo Bob' outside greeting them. They love Bob's songs, stories and welcome. After the fish and Bob, they head into the Hall, where there is the most beautiful atmosphere of anticipation and excitement – children have come to play!

There have been many conversations through the year, going something like this "at what point are we going to say we've got too many coming?" We've been forced to have conversations about how to limit numbers to the popularity of the group. The welcome to a new Mum, Dad, Carer or Grandparent always goes like this: "We run this group because as a church community we want to show God's love to you. We want to serve our community." We follow up that sentiment with action – fresh tea, coffee, toast, sofas, warm hall, care throughout.

I've just described for you the first couple of hours of a morning at Christ Church midweek, Monday to Thursday. I think the above typifies the heartbeat of our church community – we welcome people, unconditionally. We care for people, we love people. We don't do this perfectly (I certainly don't do this perfectly). But it is our direction of travel. It's what we strive to do.

I won't describe the rest of each day in as much detail but I will jog your memory briefly: hall open for tea and coffee, sometimes the craft group, holy communion in the chapel, lunch in the hall, 'Lyrics and Lunch' serving those with dementia, special needs and their carers. Dancing once a month, bowling weekly, table tennis weekly. That's as well as our long-establish church ministries such as Mothers' Union, with services, refreshments and speakers and of course, the faithful Fridaymen out in all weathers tending to the Churchyard and whatever else needs attention. Monday to Friday, there is something happening in the daytime and most evenings.

I'd like to think we have the balance between Mary and Martha. We are certainly very busy with activities of mission. But wrapping around all these are disciplines of prayer, worship and study. Morning Prayer, daily services, weekly Bible studies through our Growth Groups – on a Sunday, Monday and Tuesday. We've run many sessions of the 'Bible Course' (by the Bible Society), the Christianity Explored Course, as well as weekly bible studies through the books of 1 Peter and 2 Peter. This as well as the staple diet of things such as a Lent Course.

During the year we also launched our brand-new website, which has been a few years in planning. It works just as well on a phone, tablet or laptop. It links to our church calendar system, means people can listen to sermons online with the potential to watch videos through it (which would turn out to be particularly useful during 2020!).

Supporting all this ministry and mission requires significant investment, achieved through increased giving, a grant, and events which have raised funds. The Events Team worked hard through the year, with regular concerts which we have hosted and several indoor 'fairs' and

markets, auctions and the Vicarage Garden Party. These have been brilliant events in themselves but also raised an impressive amount for church funds and other organisations.

So much of what we're about was seen on the day we celebrate our Lord's birthday. On Christmas Day, we had the most amazing team of volunteers, who prepped, cooked and served a Christmas Day Meal for the many guests we had come for the Community Christmas Day Dinner. It wasn't just about food. It was about company, laughter, songs, gifts, warmth, smiles and joy. It was so appreciated by everyone who came. And to the many who gave up their Christmas Day – I know it didn't feel like giving up anything really, because you enjoyed it so much! Thank you. And thank you to all who serve the Lord through Christ Church year-round. It might be in public, it might be unseen. In the Hall, the Churchyard, Church, Hospital, Care Homes, in the Community.

We sadly said 'farewell' to many people once again. These are always sad occasions but not without hope. We believe our brothers and sisters in Christ pass from death into eternal life. They move out of a world where there is much pain, disease, sin and death, into God's heavenly kingdom, where Jesus wipes every tear from their eye and where death's sting has no place.

It is not possible to mention and honour every person. But it does feel appropriate to mention two people in particular, who, until their final months with us were serving the Lord with their lives. Our dear sister Celia Stott, who faithfully served the Mothers' Union, the PCC and gave the most tremendous welcome to anyone coming for their first time on a Sunday. During 2019 Revd Keith Sillis retired from his role as Honorary Assistant Priest due to ill health. We had a touching celebration in Church on the anniversary of his ordination and we'll all remember the words he shared and the emotion we all felt. At the turn of the year into 2020, our brother Keith went to be with the Lord. And it seems appropriate, after decades of worship, service and priestly ministry with us, to finish at this point, remembering him and giving honour to his Saviour, our Lord Jesus Christ, for all he does in and through us and for us at Christ Church Thornton. Jesus died, for you, for me, for Keith, so that we might all enjoy forgiveness of sins, peace with God, life eternal – that we might dwell in God's presence always. Ultimately, that's what we're all about isn't it?

PCC SECRETARY'S REPORT FOR 2019

Hebrews 10:24-25 says we should ".....consider how to stir up one another to love and good works, not neglecting to meet together....."

Everyone who attends Church is encouraged to put their names down on the Electoral Roll and to stand for election to the Parochial Church Council (PCC) and if you are at all interested in this, please see one of the Churchwardens for details and the form to fill in and then, please, stand for election to the PCC next year.

The PCC is the executive committee of the Church and comprises Clergy, Churchwardens and representatives of the laity. Legally, we are responsible for the financial affairs of the Church and also for the maintenance of its assets as well as promoting the mission of the Church.

Christ Church PCC held 6 Meetings during this last year including the Away Day which was held at Whalley Abbey on the 11th May 2019. This has started to become an Annual Event and it's where the PCC decide what their priorities are to be for the year in all aspects of their work for the Church. Although we plan a lot for the day and we work hard, it is also a time of reflection. This is possibly because of where we are and taking Communion together at the end of the day, in the Chapel, is really special. It says in Matthew 18:20 "Where two or more are gathered in my name, there am I among them."

We have decided quite a lot of things during this year, not the least of which was to have the pews removed and buy chairs. I know a lot of people are worried about how people will react and how it will all look, but we have to remember that the pews aren't original to Christ Church and don't match as the ones at the back are a completely different design from the rest. They are uncomfortable and don't lend themselves to using the Church in different ways. If we want to move with the times, we need the pews to move!

We also made the momentous decision to move PCC Meetings from the evenings to Saturday mornings. I have to say that I think this has been a resounding success. Particularly during the Autumn and Winter months, it is sometimes hard to come home, grab something to eat and leave the warm chair by the fire to come to Church for a couple of hours or more, very often tired and not concentrating properly. Now, first thing in the morning, we are bright eyed and bushy tailed and we often finish the Meetings with Communion, which is a fitting end to the time and all the work that the PCC put into supporting the many activities and events that are going on to make Christ Church an active place of worship enabling us, as a growing Church, to reach out into the community of the Parish of Thornton-le-Fylde.

To be a PCC Member is to be a Trustee of the Church – and our duties are laid down by the PCC (Powers) Measure of 1956, which says we should co-operate with the Minister in promoting in the Parish, the mission of the Church, pastoral, evangelistic, social and ecumenical.

If you have skills that you think would help the PCC plan the future for Christ Church, then please stand for election to the PCC and bring your talents to our Committee. As in Romans 12:4-5 "For as in one body we have many members and the members do not all have the same function, so we, though many, are one body in Christ and individually members one of another."

TREASURER'S ANNUAL REPORT

Summary

Christ Church is incredibly blessed to have many committed and generous volunteers as part of its PCC and wider leadership teams. Management of income and expenditure has been carefully managed by the Parish Manager and Finance Assistant, informed by budget forecasts which help the PCC to track income and expenditure across the calendar year. Most importantly, the budget forecast is designed around our strategic vision for growth, the aim of which is to reach out into the community and increase regular worshippers. As part of that vision, the PCC agreed to a staff recruitment strategy for making better use of the church estate, including the churchyard.

During 2019 the PCC, wider leadership teams, and other volunteers have worked hard to improve the offer Christ Church makes to help enrich the spiritual and community lives of our Parishioners (existing and new) and those that are starting their Christian journey. The activities, described in greater detail in Reverend Damian Platt's report, demonstrates how successful this has been, helping to make the Christian faith relevant in and beyond our local community, bringing people to Christ.

Regular worshippers have increased from around 125 to 150 and compared to 2018, voluntary giving (excluding gift aid recovered) has increased by around 37%.

Restricted Income

The restricted reserves arose from the sale of a section of the graveyard in 1973. The proceeds from this sale were invested in 8,071 shares in Church of England Investment Fund. This fund is heavily restricted by extant legally binding documents for the sole use of the upkeep and care of the Church and churchyard and for no other purpose. The terms of the restricted reserves relate specifically to the "...improvement and maintenance of the parish church and churchyard of the parish of Christ Church.....".

Access to the Restricted Reserves is through request to the Blackburn Diocese Board of Finance Limited. Payment is made into the current account. Access to Restricted Reserves during 2019 continued to focus on supporting the salary costs of our paid Sexton and Sexton Assistant/Horticultural Apprentice. During 2019 £21,783 was withdrawn from the Restricted Reserves. The balance as at 31st December 2019 is £38,835 (£60,216 December 2018).

Unrestricted reserves

Christ Church has a Deposit Fund savings account with no restrictions. The funds have been drawn down over time and used, where necessary, to ensure the current account remains in credit. The balance as at 31st December 2019 was £210 (£208 December 2018).

Current Account

Balance as at 31st December 2019 was £24,400 (£19,028 December 2018).

Fees Account

The Fees Account is described as the Churchyard Account. Fees for weddings, baptisms etc are paid into this account, with fees to the Diocesan paid out of this account. The account balance as at 31st December 2019 was £5,636 (£6,623 December 2018).

The reduction reflects the nationwide reduction in weddings, baptisms and funerals taking place in church.

Parish Share

During 2019 Christ Church paid £40,000 to the Parish Share (£30,000 in 2018). This is just over half of the estimated full Parish Share for 2019 - £73,545.

The Blackburn Diocese Board of Finance Limited, informed by the PCC's vision for growth, agreed the reduction in the estimated Parish Share for a third year.

The PCC recognise the importance of the Parish Share in supporting clergy and parishes right across the country, which is why the reduction remains a temporary measure. Our aim, in line with the PCC's strategy is, over time, to increase its contribution to the Parish Share through investment in mission and growing the wider church family.

Staffing

Employed staff during the year included: Choir Master/organist; Parish Assistant; Sexton; Sexton Assistant/Horticultural Apprentice; Welcomer/Verger and Facilities Assistant. Self-employed staff include: Parish Manager; Finance Assistant/Bookkeeper.

Staffing costs

Staffing costs during 2019 were £70,915, (£52,980 December 2018).

Staffing costs for 2019 included a grant of £14,981 the PCC received from the Walney Community Extension Fund (to support the Community Centre).

Staffing costs include Christ Church contribution to the National employment Savings Trust (NEST Pension Scheme) and other 'on costs' e.g. National Insurance contributions. We did not apply for any grants in 2018. Staffing costs were around 46% of our total income in 2019.

The proportion of staffing costs maybe a little higher than expected for a non-profit making organisation of our size (the average for which is around 20% of total income).

Staffing costs are kept under careful review and continues to support the PCC's strategic vision to support growth.

Income and Expenditure

Expenditure exceeded income. Total income from voluntary giving and other receipts was £153,115 (compared to £109,321 in 2018), less total payments of £169,119 (compared to £141,985 in 2018).

Balancing income and expenditure

In addition to the essential running costs for the church estate, we spend around £36,000 a year on maintaining the churchyard and receive, on average, around £12,000 towards those costs.

The mean average of weekly giving to Christ Church, based on 150 regular worshippers and planned giving, collections at services and other giving/voluntary receipts, excluding gift aid recovered, is around £10.89 per week.

It is important to stress that this is an estimated average. Christ Church is blessed in that it receives donations considerably higher and that giving is received out of grace and a wish to grow the Christian faith. It would be wrong to assume the financial circumstances are the same for everyone. For these reasons Christ Church has taken steps to engage in income generating activities, Stewardship Campaigns, but for its core income relies heavily on voluntary donations.

If giving, as described earlier, increased to a mean average of £15 per week, based on 150 regular worshippers, this could generate £117,000, approximately £32,000 additional income (with a potential increase in gift aid).

Increasing weekly giving in the way described could provide important financial flexibility to help the PCC meet its financial obligations necessary to operate a large church estate, whilst keeping people safe, helping the PCC to invest in church, community and wider outreach activities.

This is of course a rather simple comparison, but the important point to note is that increasing weekly giving would make a material difference to our ability to meet our expenditure, invest in mission and over time, increase our contribution to the Parish Share.

The PCC recognises how blessed Christ Church is for the long standing and committed army of volunteers who, together with our paid colleagues, are focused on maintaining the church estate, the churchyard, income generation and a whole host of activities designed to help put Christ Church at the heart of community and supporting the spiritual well-being of the church family. The continued generosity through financial and non-financial support is invaluable, without the efforts of all those that contribute to the life and viability of Christ Church, we could not realise the PCC's strategic vision.

The PCC will continue through its prudent management of its' income, ensure funds are spent wisely with the primary focus on making disciples of Jesus Christ.

MOTHER'S UNION REPORT

The vision of the Mothers' Union today is a world where God's love is shown through loving, respectful and flourishing relationships. Our mission is to demonstrate the Christian faith in "Building hope and confidence." To help those whose family life has met with adversity in our own community and communities worldwide.

At the end of 2019 our membership stood at 65. Unfortunately, we lost several members during this time. Hilda Berry, Anita Macdonald, Amy Penty, Madge Apperley, Joan Ramsey, Celia Stott, Mary Astin and Margaret Martlew. We give thanks for their dedication and friendship to the Mothers' Union over many, many years and we give thanks for the privilege of knowing them. On a happier note we had the privilege of welcoming Carol Hull into our family as a new member and Hazel Nicholls (already a member) into our branch at Christ Church.

The branch continued to meet on the first Wednesday afternoon of the months January to April and September to December. Our Corporate Communion Service continued throughout the year on the third Wednesday of each month.

Lent Lunches were once again held for 6 weeks and were very well supported. Donations from the lunches raised £701.50p. Our "Afternoon Tea" event in June raised a further £367.50. These events enabled substantial donations to be made towards the work of the Mothers' Union. These included Overseas, World Wide Relief and Literacy & Development. In our own Diocese there was Action and Outreach, AFIA Holiday Scheme, Care for Indoor Members and Faith and Policy. Our faithful knitters and many others from our church family continued to knit hats and blankets for the premature babies in the Neo-Natal Unit at Blackpool Victoria Hospital.

Our Policy Statement 'Promoting a Safer Church'

- In accordance with the Church of England Safeguarding Policy Christ Church Thornton is committed to:
- Promoting a safer environment and culture.
- Safely recruiting and supporting all those with any responsibility related to children, young people and vulnerable adults within the church.
- Responding promptly to every safeguarding concern or allegation.
- Caring pastorally for victims/survivors of abuse and other affected persons.
- Caring pastorally for those who are the subject of concerns or allegations of abuse and other affected persons.
- Responding to those that may pose a present risk to others.

The Parish will:

- Create a safe and caring place for all.
- Have a named Parish Safeguarding Officer (PSO) to work with the incumbent and the PCC to implement policy and procedures.
- Safely recruit, train and support all those with any responsibility for children, young people and adults to have the confidence and skills to recognise and respond to abuse.
- Ensure that there is appropriate insurance cover for all activities involving children and adults undertaken in the name of the parish.
- Display in church premises and on the Parish website the details of who to contact if there are safeguarding concerns or support needs.
- Listen to and take seriously all those who disclose abuse.
- Take steps to protect children and adults when a safeguarding concern of any kind arises, following House of Bishops guidance, including notifying the Diocesan Safeguarding Adviser (DSA) and statutory agencies immediately.
- Offer support to victims/survivors of abuse regardless of the type of abuse, when or where it occurred.
- Care for and monitor any member of the church community who may pose a risk to children and adults whilst maintaining appropriate confidentiality and the safety of all parties.
- Ensure that health and safety policy, procedures and risk assessments are in place and that these are reviewed annually.
- Review the implementation of the Safeguarding Policy, Procedures and Practices at least annually.
- Each person who works within this church community will agree to abide by this policy and the guidelines established by this church.
